According to the USA Immigration, all ESTA eligible passengers who visited Cuba from January 12th, 2021 cannot travel to the United States with the ESTA but have to apply for a US VISA via Embassy/Consulate. This travel restriction also refers to all those with dual citizenship of a VWP country and Cuba at the time they apply for ESTA.

Passengers who have visited the island before 12th January 2021 are not affected by this measure.
